# **What This Privacy Policy Covers**

- This policy covers how TBAIF treats personal information that TBAIF collects and receives, including information related to you're past use of TBAIF products and services. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.
- This policy does not apply to the practices of companies that TBAIF does not own or control, or to people that TBAIF does not employ or manage.

## **Information Collection and Use**

#### General

- TBAIF collects personal information when you register with TBAIF, when you use TBAIF products or services, when you visit TBAIF pages or the pages of certain TBAIF partners, and when you enter promotions or sweepstakes. TBAIF may combine information about you that we have with information we obtain from business partners or other companies.
- When you register we ask for information such as your name, email address, birth date, gender, zip
  code, occupation, industry, and personal interests. For some financial products and services we may
  also ask for your address, Social Security number, and information about your assets. Once you
  register with TBAIF and sign in to our services, you are not anonymous to us.
- TBAIF collects information about your transactions with us and with some of our business partners, including information about your use of financial products and services that we offer.
- TBAIF automatically receives and records information on our server logs from your browser, including your IP address, TBAIF cookie information, and the page you request.
- TBAIF uses information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

#### Children

- When a child under age 13 attempts to register with TBAIF, we ask that he or she have a parent or guardian create a TBAIF Family Account to obtain parental permission.
- TBAIF will not contact children under age 13 about special offers or for marketing purposes without a parent's permission.
- TBAIF does not ask a child under age 13 for more personal information, as a condition of participation, than is reasonably necessary to participate in a given activity or promotion.

# **Information Sharing and Disclosure**

- TBAIF does not rent, sell, or share personal information about you with other people or nonaffiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:
  - We provide the information to trusted partners who work on behalf of or with TBAIF under confidentiality agreements. These companies may use your personal information to help TBAIF communicate with you about offers from TBAIF and our marketing partners. However, these companies do not have any independent right to share this information.
  - We have a parent's permission to share the information if the user is a child under age 13. Parents have the option of allowing TBAIF to collect and use their child's information without consenting to TBAIF sharing of this information with people and companies who may use this information for their own purposes;
  - We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims;
  - We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of TBAIF's terms of use, or as otherwise required by
  - We transfer information about you if TBAIF is acquired by or merged with another company.
    In this event, TBAIF will notify you before information about you is transferred and becomes subject to a different privacy policy.

- TBAIF displays targeted advertisements based on personal information. Advertisers (including ad serving companies) may assume that people who interact with, view, or click on targeted ads meet the targeting criteria for example, women ages 18-24 from a particular geographic area.
  - TBAIF does not provide any personal information to the advertiser when you interact with or view a targeted ad. However, by interacting with or viewing an ad you are consenting to the possibility that the advertiser will make the assumption that you meet the targeting criteria used to display the ad.
  - TBAIF advertisers include financial service providers (such as banks, insurance agents, stock brokers and mortgage lenders) and non-financial companies (such as stores, airlines, and software companies).

#### Cookies

- TBAIF may set and access TBAIF cookies on your computer.
- TBAIF lets other companies that show advertisements on some of our pages set and access their cookies on your computer. Other companies' use of their cookies is subject to their own privacy policies, not this one. Advertisers or other companies do not have access to TBAIF's cookies.
- TBAIF uses web beacons to access TBAIF cookies inside and outside our network of web sites and in connection with TBAIF products and services.

## Your Ability to Edit and Delete Your Account Information and Preferences General

- You can edit your TBAIF Account Information, including your marketing preferences, at any time.
- New categories of marketing communications may be added to the Marketing Preferences page from time to time. Users who visit this page can opt out of receiving future marketing communications from these new categories or they can unsubscribe by following instructions contained in the messages they receive.
- We reserve the right to send you certain communications relating to the TBAIF service, such as service announcements, administrative messages and the TBAIF Newsletter, that are considered part of your TBAIF account, without offering you the opportunity to opt-out of receiving them.
- You can delete your TBAIF account by visiting our Account Deletion page. Please click here to read
  about information that might possibly remain in our archived records after your account has been
  deleted.

## Children

- Parents can review, edit, and delete information relating to their child's TBAIF account using tools offered by TBAIF Family Accounts.
- If a parent chooses not to allow us to further collect or use a child's information, parents enrolled in TBAIF Family Accounts can delete their child's account by signing into that child's account and then visiting our Account Deletion page. Please click here to read about information that might possibly remain in our archived records after your account has been deleted.

## **Confidentiality and Security**

- We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.
- We have physical, electronic, and procedural safeguards that comply with federal regulations to protect personal information about you.
- Your TBAIF Account Information is password-protected.
- In certain areas TBAIF uses industry-standard SSL-encryption to protect data transmissions.
